Past Issues

A number of transportation projects are currently underway or will begin soon in our neighborhood. Here are updates on the major projects.

- Beach Drive has been open since September 30th! Reconstruction is complete.
- Wise Road is open after being resurfaced!
- Bingham Drive remains closed and will be re-paved. DC Water will provide information on this project at the ANC's October 28 meeting.
- Oregon Avenue from Military Road to Western Avenue will undergo a complete renovation over three years beginning this fall.

- The Commission voted 5-0 to support a special exemption at 3917 Military Road NW to build an addition consistent with an existing one-foot side yard variance.
- The Commission voted 5-0 to approve testimony for the DC Council Committee on Facilities and Procurement's Public

HOW TO INFLUENCE THE DISTRICT'S BUDGET

The District's Fiscal Year 2020 budget year began on October 1, 2019, but the process is already underway to set the budget for FY 2021. We're all affected by what the Mayor and the Council decide to fund through the budget — e.g., how much money will be available to repair roads, alleys, and sidewalks, what funding will go to school improvements, and whether the District will pay its share for DC Water's massive Clean Rivers program. Most citizens, however, don't know how those budget decisions are made or how they can help shape budget priorities.

The Mayor began developing the FY 2021 budget over the past summer, when each of the more than 100 District agencies reported the expenses that will be necessary to continue the current level of services. Beginning in October, the Mayor's office and the Office of Budget and Planning give agencies their citywide strategic plan and specific budget guidance for developing funding levels for both operating and capital expenses. Meanwhile, the Office of the Chief Financial Officer projects expected revenues. The agencies submit their budget proposals in December, and, after a review to identify possible efficiencies and to match expenses with

ANC3/4G REVIVES FACEBOOK ACCOUNT

Based on the recent survey ANC3/4G conducted which examined how our community uses social media we are reviving our long dormant Facebook account. In our survey 22.5% of respondents indicated they would like to get information via Facebook which was more than double any other social media platform. This made it clear that at this time Facebook is the preferred social media choice within our ANC. This does not mean we are abandoning other means of communication but for our over 430 current Facebook followers we will be keeping our account current and updated with both ANC and neighborhood news. We hope you will come to count on our Facebook account for useful information. So, if you don't already follow us please do and look for us to be active with our posts.

Using the Mayor's proposal as the baseline, the Council holds public hearings in March to review each agency's budget. The Council often makes changes to reorder priorities, and prepares a revised budget that it usually passes in early June. Assuming that the Mayor agrees to the Council's changes, she approves it and sends it to the President for submission to Congress, which must ultimately act on it.

Much of this process takes place out of the public's eye, but there are ways that residents both individually and through the ANC — can influence what's included in the final budget. First, we can begin now to ask agency directors and the Mayor to consider proposing funding for important community projects. ANC 3/4G followed this route in seeking funding to modernize the Chevy Chase Community Center, and the Mayor included our proposal in her FY 2019 budget. Second, we can testify at the Council's budget hearings to advocate new, expanded, or reduced agency funding. The ANC testified at six FY 2020 budget hearings and successfully persuaded the Council to fund programs that will support our community.

The District's budget may appear opaque, but there are ways that citizens can influence how our tax dollars get spent. Let your ANC commissioner know if there are particular funding needs, and we will work together to have them considered in the budget.
