**ANC 3/4G Resolution
For the Commission to Foster
More Informed Community Engagement
in the Chevy Chase Small Area Plan**

April 12, 2021

BE IT RESOLVED that the Commission will carry out a community outreach program to bolster and ensure broad community engagement, transparency, and information exchange regarding the Chevy Chase Small Area Plan process and designates Commissioner Chang, ANC 3/4G-05, to represent the Commission in all matters relating to this program.

RATIONALE

The Commission has been involved with the latest five-year DC Comprehensive Plan since its inception and has been instrumental in initiating a Small Area Plan that provides supplemental and more detailed guidance to the "Comp Plan." With an operating budget of \$150,000 for FY2021, DC's Office of Planning started work on the Chevy Chase Small Area Plan in December 2020. Community engagement via the project website and an initial public meeting commenced in the first quarter of 2021. The Office of Planning's virtual "public kick-off" meeting in early March 2021 was not well received, however, by the community, which has led to the Commission's determination that an enhanced public engagement process would be beneficial. This Commission initiative is designed to complement the Office of Planning's engagement process in a spirit of partnership and cooperation to foster a positive vision for the future of the Chevy Chase neighborhood. As a service to the community, the Commission has

provided extensive background documents, including an account of the Chevy Chase Small Area Plan planning and engagement process. These are available on the ANC3/4G website.

DETAILS

1 – The Commission will host a series of conversations on neighborhood development via community meetings and other appropriate means to provide a forum for considering land use, zoning, residential issues including affordable housing, nonconventional forms of ownership, and the social, economic, and other impacts of the Chevy Chase Small Area Plan.

With the aim of complementing the Office of Planning’s engagement process, the topics covered will be based on community questions and needs to help the community reach a greater understanding of complex issues related to neighborhood development.

2 – The Commission offers to organize this series in partnership with members of the Chevy Chase Small Area Plan Community Advisory Committee, members of its own Standing Committee on Racial and Social Equity, other local civic organizations, and individuals with interest in Chevy Chase, DC, depending on the topic. It is expected that thought leaders, planners, professionals, and others with knowledge, professional experience, and diversity of opinion will be invited to lead the conversation and address questions to help our community make sense of complex issues.

3 –The Commission expects to launch the planning of this series in late April 2021 and engage in outreach efforts, as appropriate, until the Chevy Chase Small Area Plan is completed and delivered to the Council for deliberation and approval.

5 – The first planning meeting will be open to the public and held virtually on Tuesday, April 20, 2021 at 7 pm. Details will be made available on the ANC website.
