I write concerning a Public Space application (Case No. 391221) filed by Loree Lipstein, 5619 Western Avenue NW, Washington, DC for permission to widen her driveway, a small portion of which extends beyond the building restriction line. The Public Space Committee is scheduled to take up this matter at its <a href="https://doi.org/10.1007/jhp.10.22">Thursday, Sept. 22nd meeting</a>. (See item # 57.) You are listed as coordinator for the Committee on its website.

I seek to notify the Committee that, at its regularly scheduled and duly noticed meeting on Sept. 12, 2022, ANC 3/4G voted unanimously to support Ms. Lipstein's application. She is a constituent. I have inspected the site. My ANC colleagues and I believe hers is a modest proposal that will not in any way adversely affect the public. Ms. Lipstein has the support of her immediate neighbors.

In the eight days since the Coimmission voted its support, I have had trouble identifying to whom I should direct this notification. Given that the PSC hearing is only 48 hours away, I intend to widely distribute it, including to DDOT Director Everett Lott, in hopes the fact of the ANC's support makes it into the PSC record in time for the Thursday hearing.
