In some cases we can find a storefront. For example, when we closed Cleveland Park we found a tiny storefront in Van Ness at UDC. In other instances we work with partners in the community to deliver library services more creatively. The interim services are funded from the project itself — there's no separate budget — so we need to keep in mind that however much we invest in an interim facility we cannot invest in the actual project.

I hope there will be consideration of not necessarily putting the library right next to the sidewalk. Right now, there are two mature oak trees between the sidewalk and the library, and green space. Although some want the "urban" look with the building up to the sidewalk, I think there is value in maintaining the green space buffer and the trees, which have enormous environmental benefits (immense carbon capture, cleaning pollutants from the air, absorbing groundwater) and provide much-needed shade in the summer. I would also think that, with housing on the site, it will be much more pleasant for those living there to have a buffer from the street. I'd much rather see a tree outside my window than Connecticut Avenue traffic, and have shade, birds, etc.
