Board of Elections, 402,323 ballots were proactively mailed out to voters ahead of the June primary, of which 65,398 were returned as undeliverable. Ahead of the November general election, 508,543 ballots were mailed out, and 87,921 were returned as undeliverable.

"That amounts to undeliverable rates of 16% and 17%, respectively, higher than the 11% undeliverable rate D.C. faced in the Nov. 2020 general election and well above the national average of 1.4%
