Is this in reference to "dockless" bikes and scooters? These are owned and operated by private operators, but managed by DDOT. If you see a misparked device in public space, you can submit a 311 request and companies are required to correct the issue within three hours.

Capital Bikeshare bikes are "docked", meaning they need to be returned to a station at the end of their trip so they should not be blocking sidewalks. One exception is our new ebikes, which are "hybrid", meaning they can be docked or locked out-of-station at a bike rack or other piece of street furniture for a \$2 fee. We have found that the vast majority (I believe over 80%) of CaBi ebikes are docked at the end of their trips

Claudia, these are known as "dockless" bicycles and scooters and are owned and operated by private companies. Users have been required since October 2021 to lock their device to a bike rack or other piece of street furniture at the end of their trip, but we understand this does not always happen.
