ANC 3/4G Resolution On Grant Applications July 24, 2023

BACKGROUND & RATIONALE

- 1) ANC 3/4G awards community grants in accordance with D.C. Code, Section 1-309.13(m). ANC 3/4G's grant guidelines and application information can be found on our website at: https://anc3g.org/about/community-grants/
- 2) ANC 3/4G typically announces the availability of community grants in mid-September and sets an October deadline for receiving applications. Eligible groups may then make a presentation at an ANC meeting following the grant application deadline.
- 3) ANC 3/4G's grant guidelines allow the ANC to "consider other grant requests that fall outside of our formal grant cycle on an as needed basis, subject to grant guidelines, grant priorities, and funding availability."
- 4) Due to community interest in ANC 3/4G community grant awards and the ANC's unusually high balance of funds (\$41,384.53 as of July 12, 2023), ANC 3/4G will provide an earlier grant application cycle, in addition to the normal cycle.
- 5) Grant funding is limited, and it is up to the ANC to decide which, if any, applications are award grant funds.

RESOLVED

- 5) **Early Grant Application Period**. ANC 3/4G will accept grant applications upon the passage of this resolution and will accept all applications until August 24. The ANC may then allocate time for grant applications presentations at our September 4 meeting and/or September 18 meeting and vote on the grant awards at those meetings.
- 6) **Traditional Grant Application Period.** ANC 3/4G will hold its traditional grant funding cycle and begin accepting grant applications on September 15 and will accept applications until October 16. The ANC may then allocate time for grant applications presentations at October and/or November ANC meetings and vote on the grant awards at those meetings.
