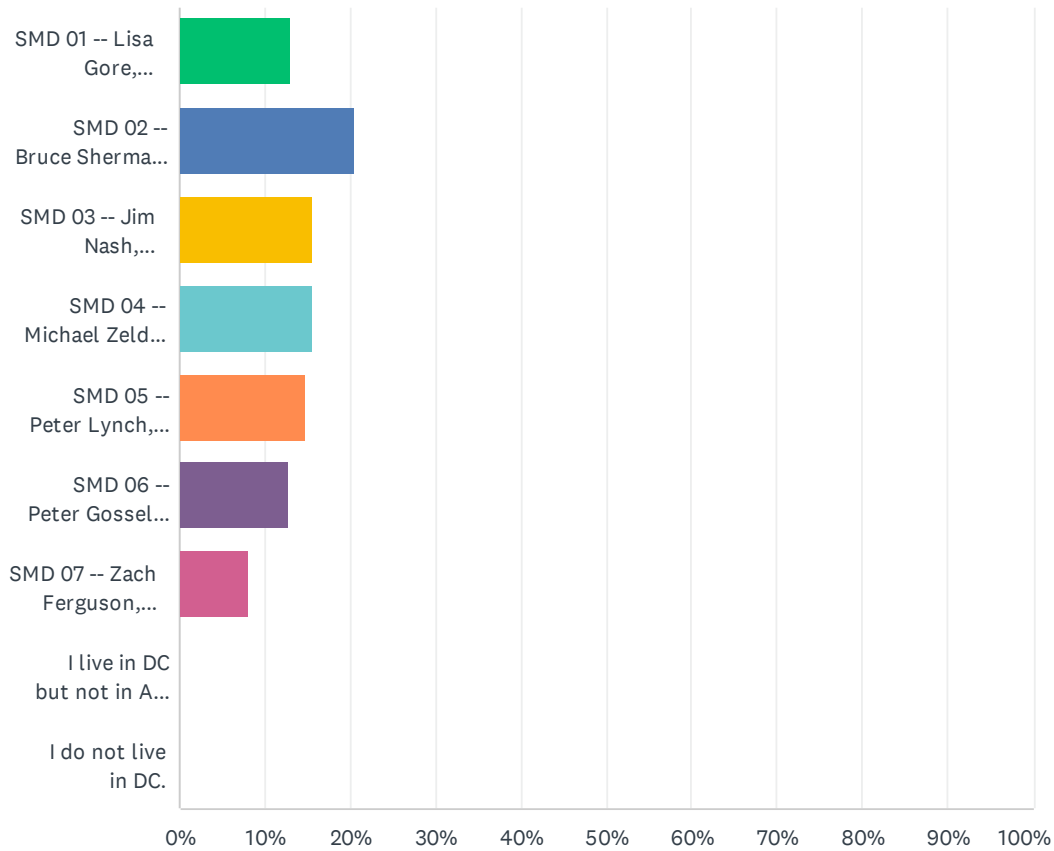

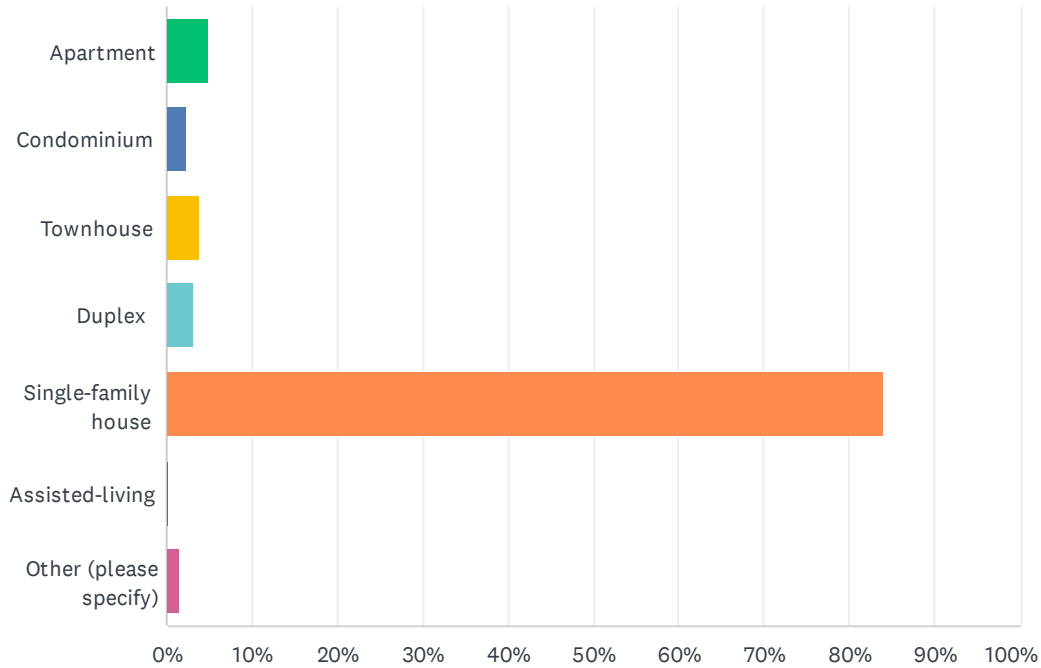

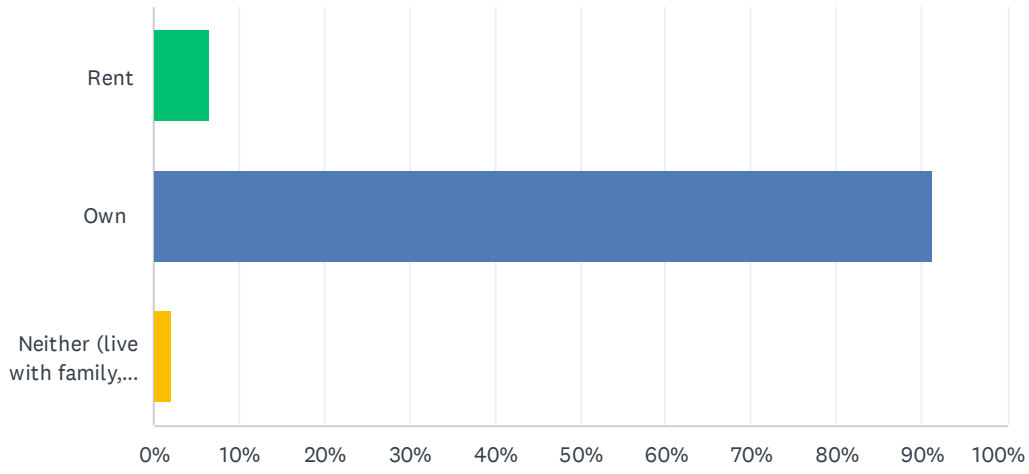

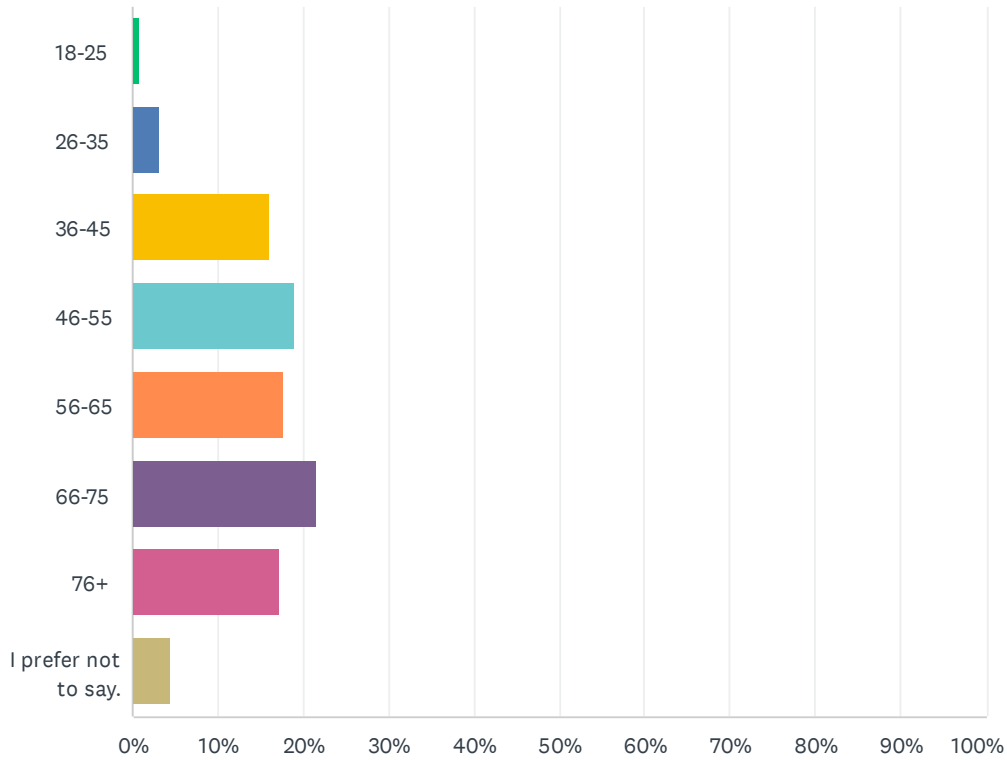

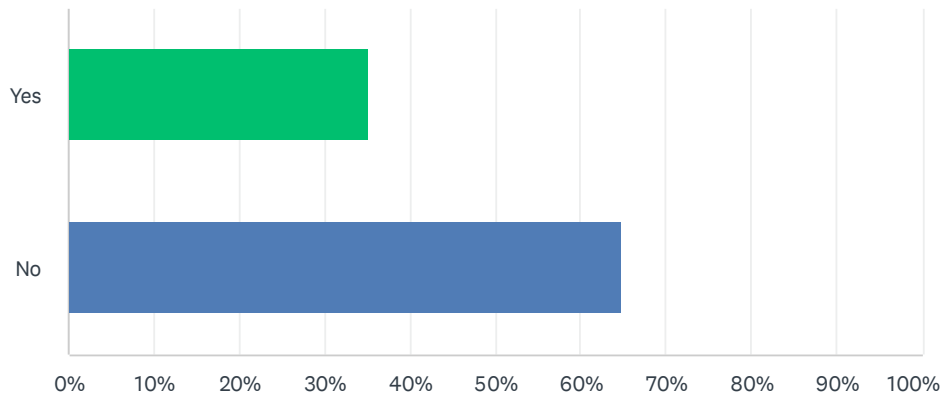

## Q5 Do you have children aged 18 or under living with you?

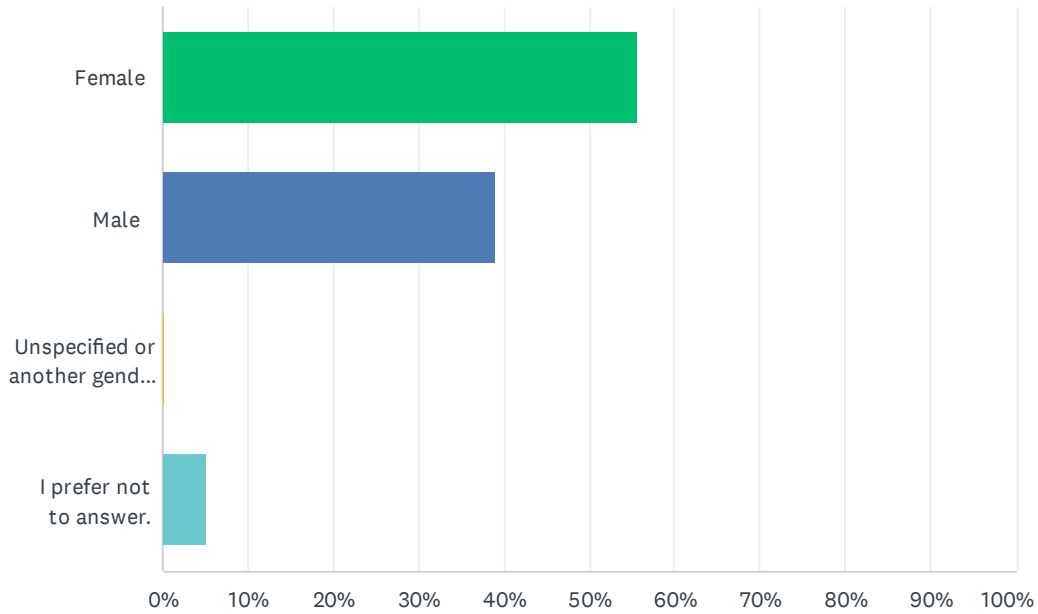

## Q6 What is your gender?

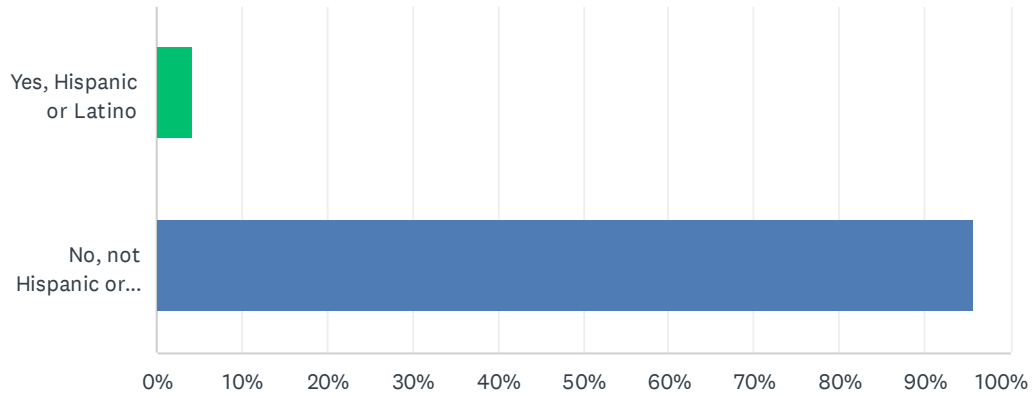

## Q7 Are you Hispanic or Latino?

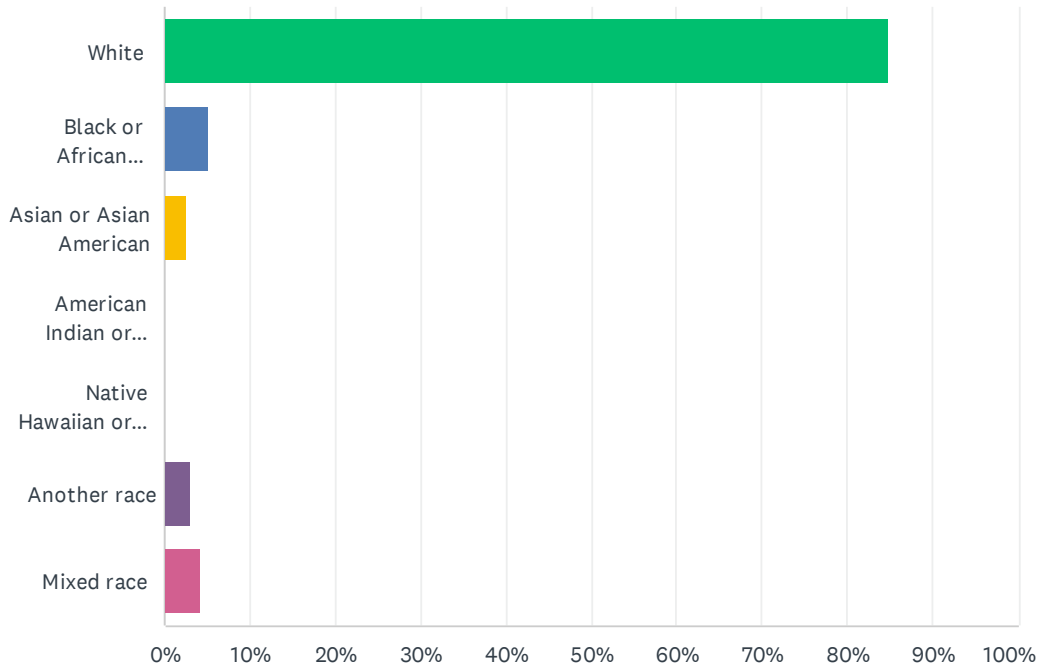

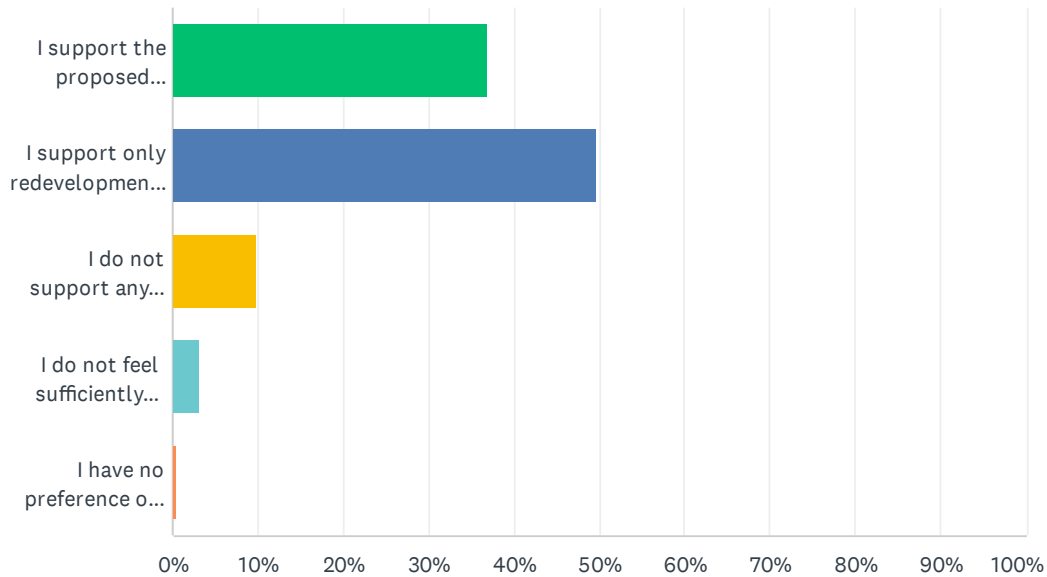

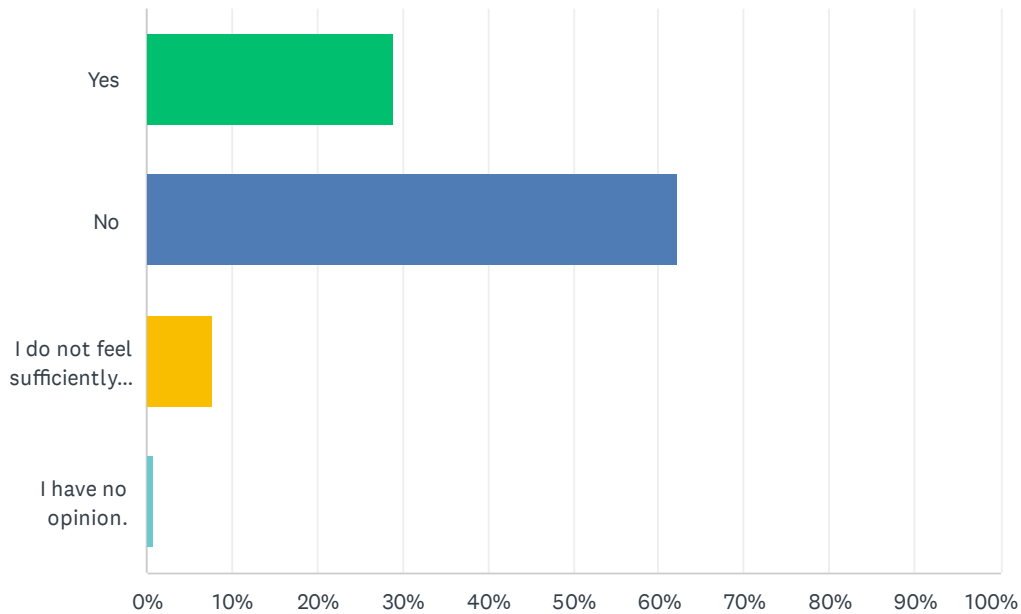

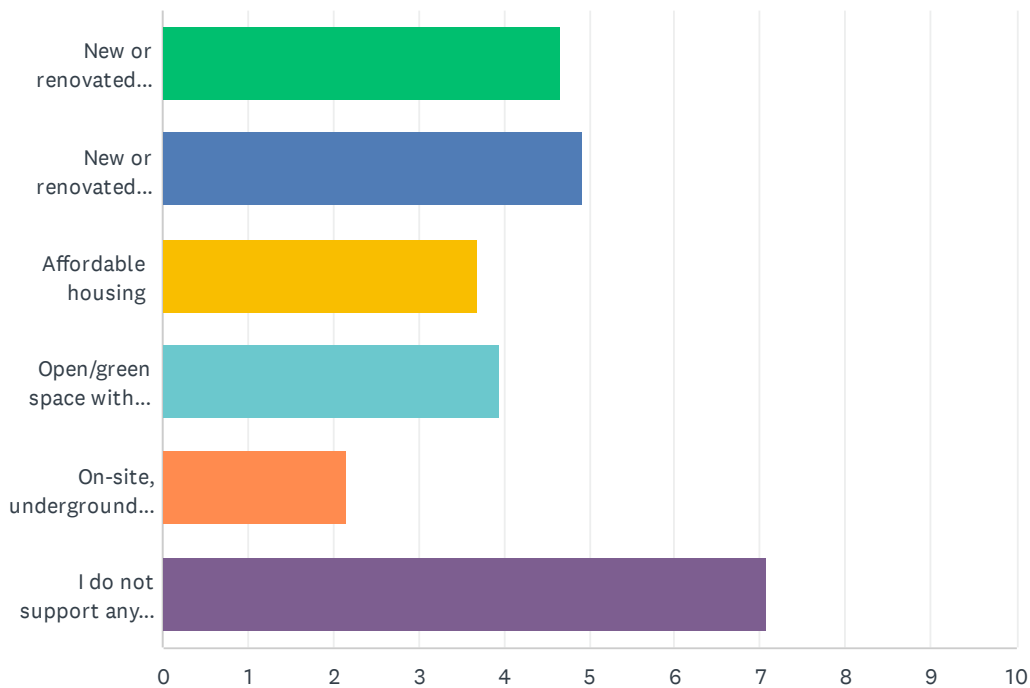

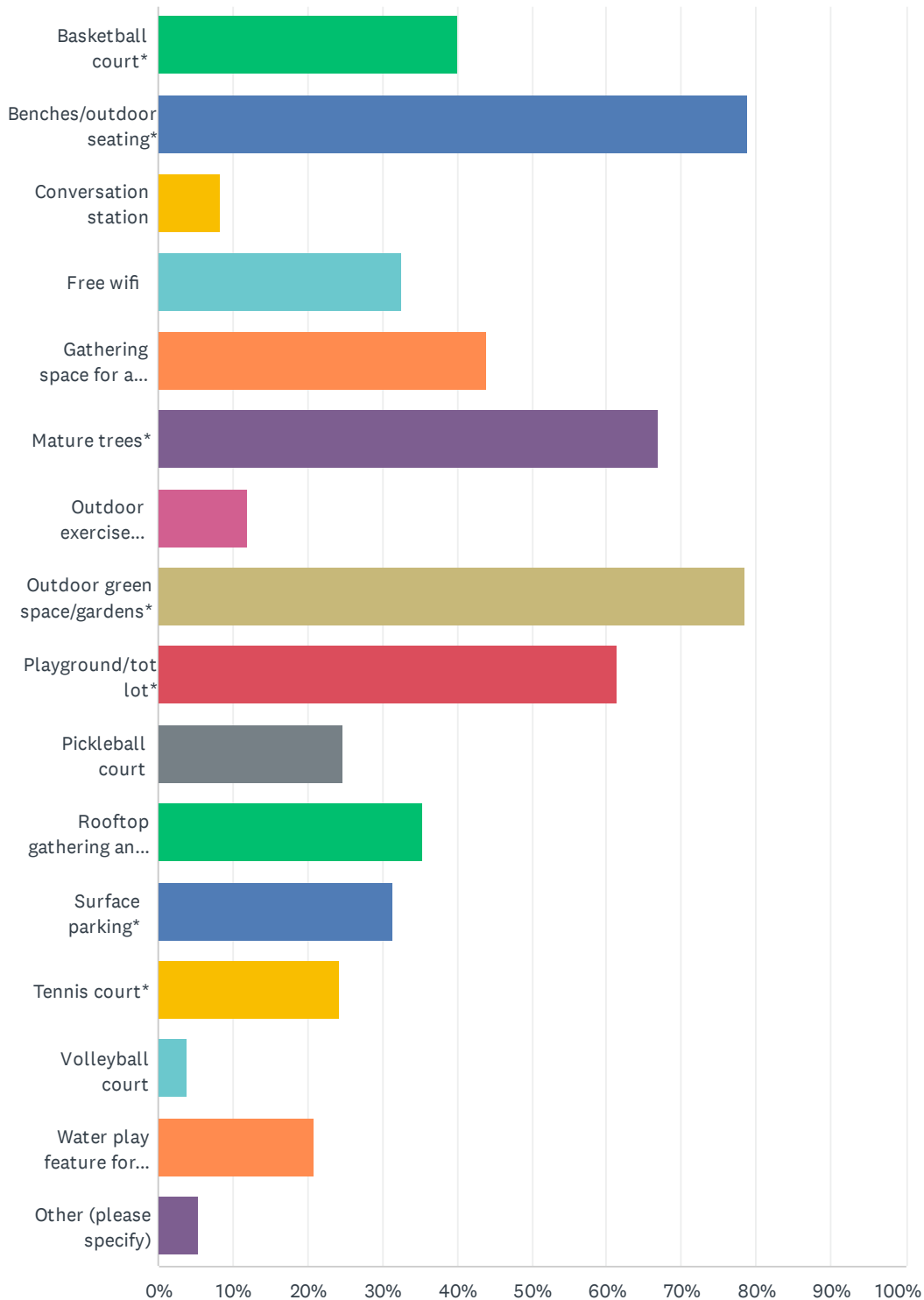

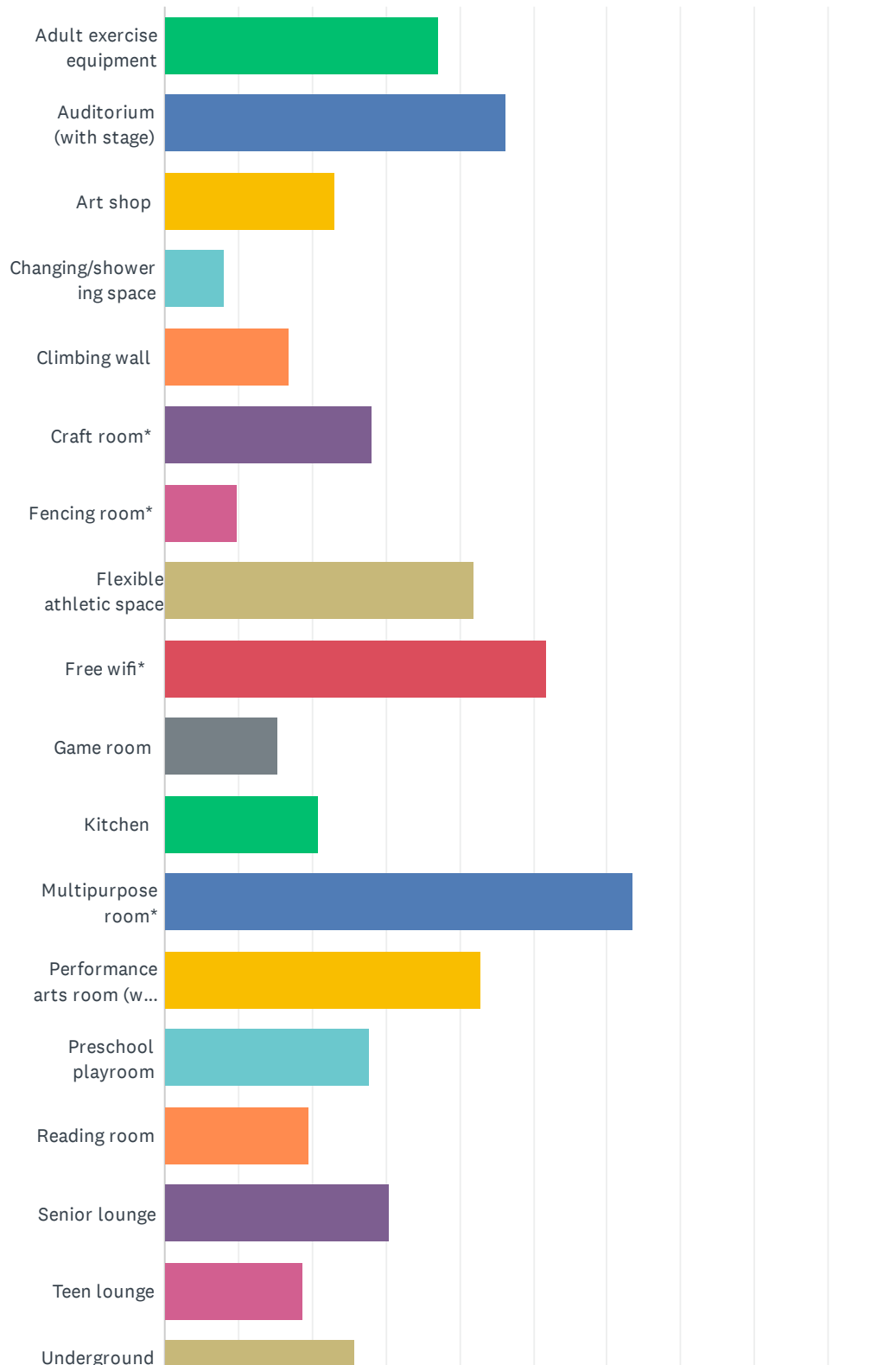

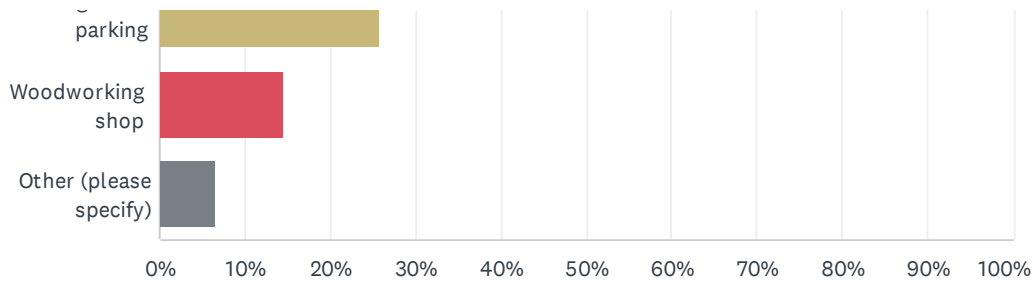
Q14 Which indoor amenities would you most like to have in a new (or renovated) Community Center? Check up to seven. (\* below denotes current amenity).

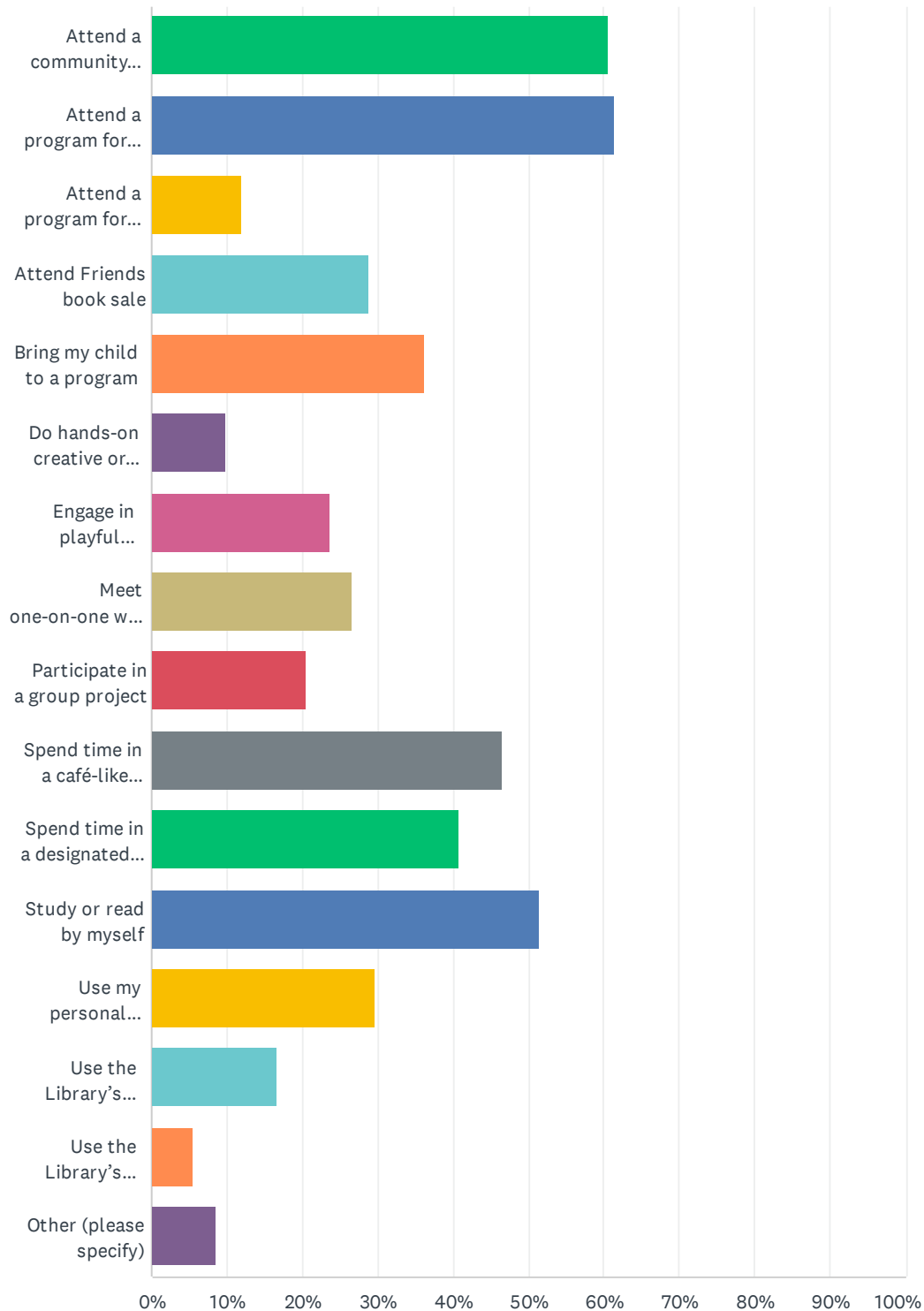

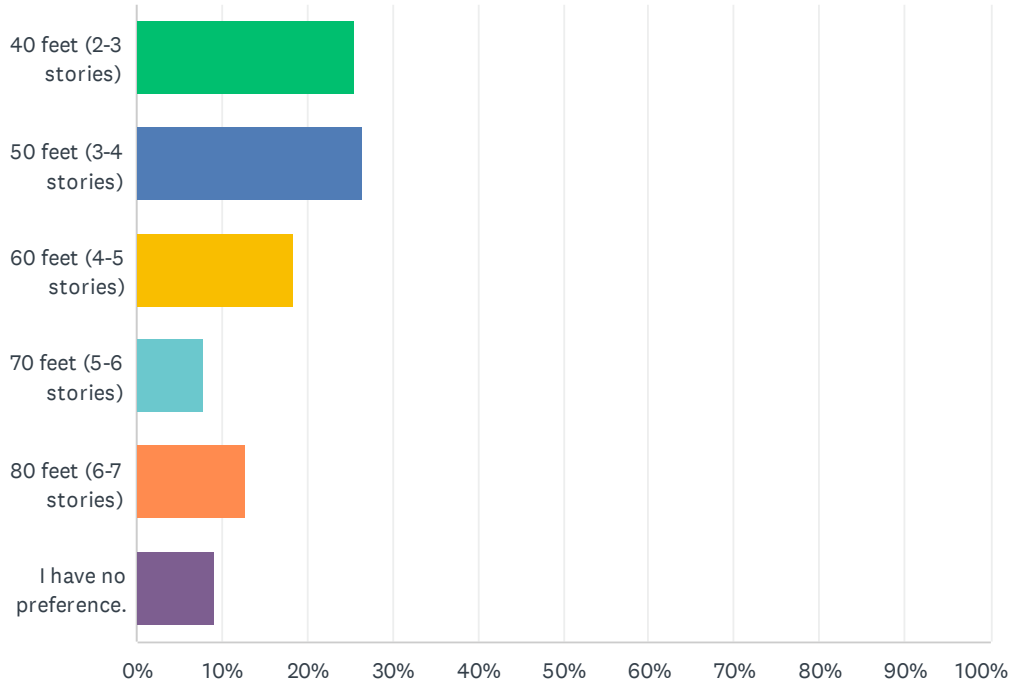

## Q16 What is the maximum building height you would support for the Community Center and Library site?

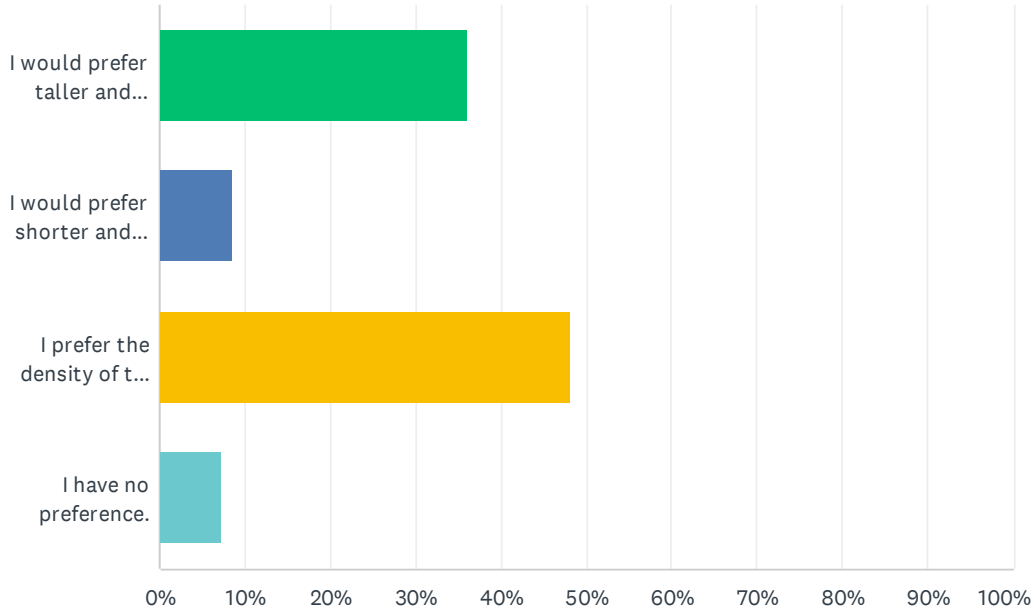

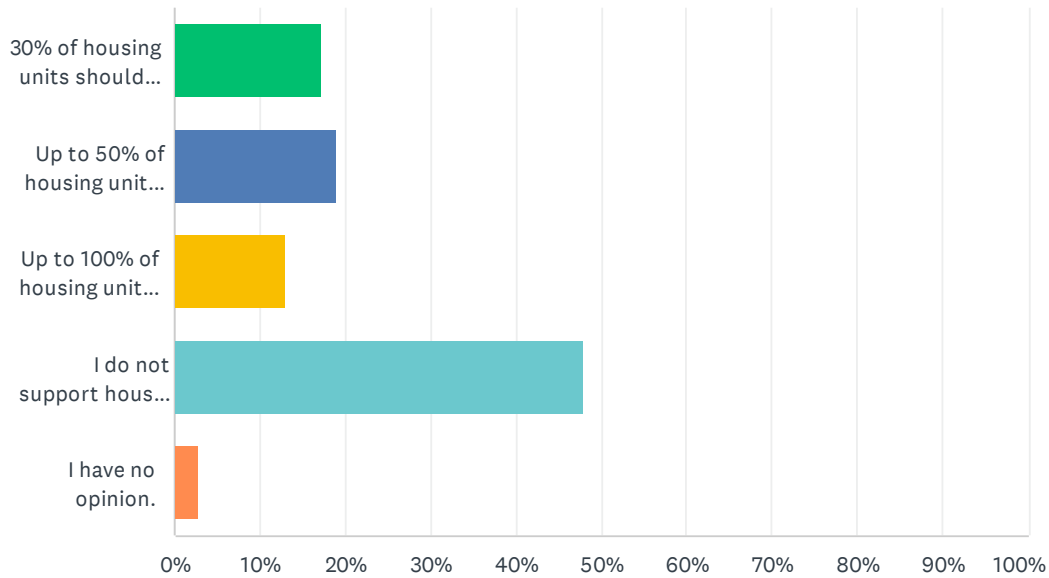

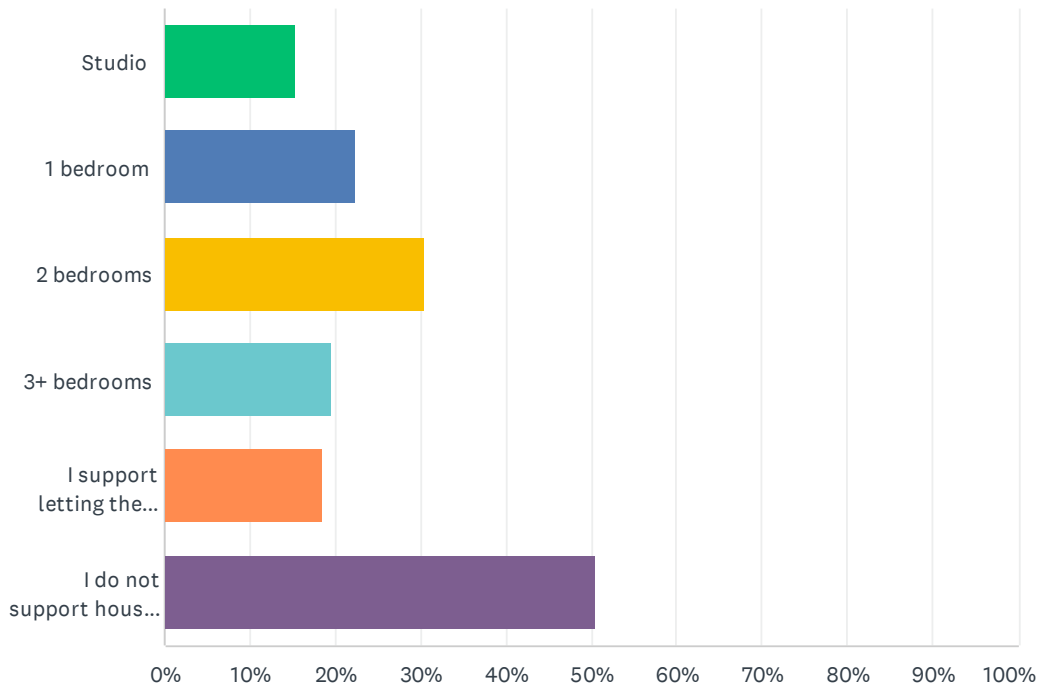

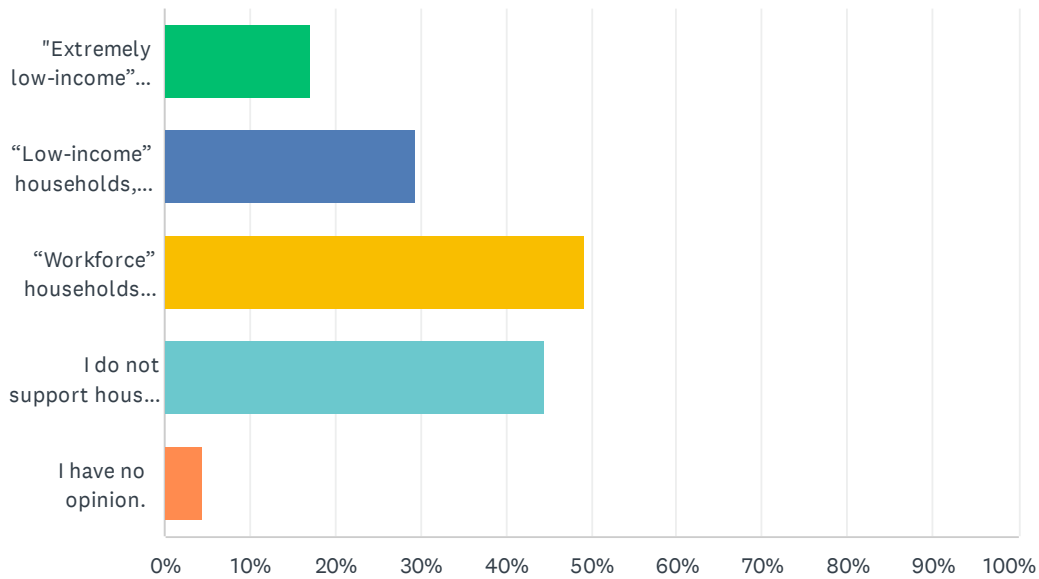

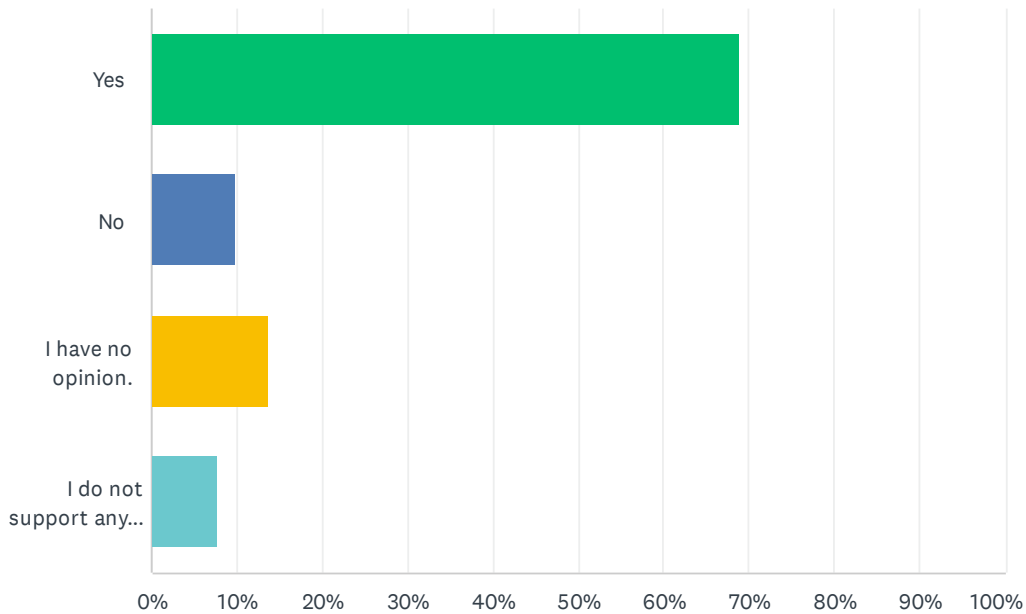

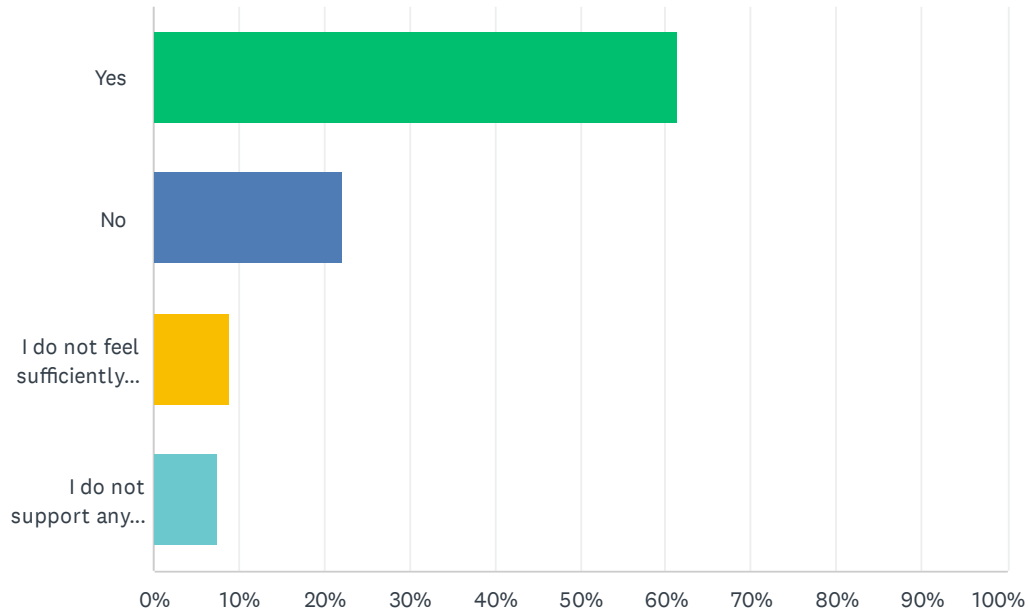

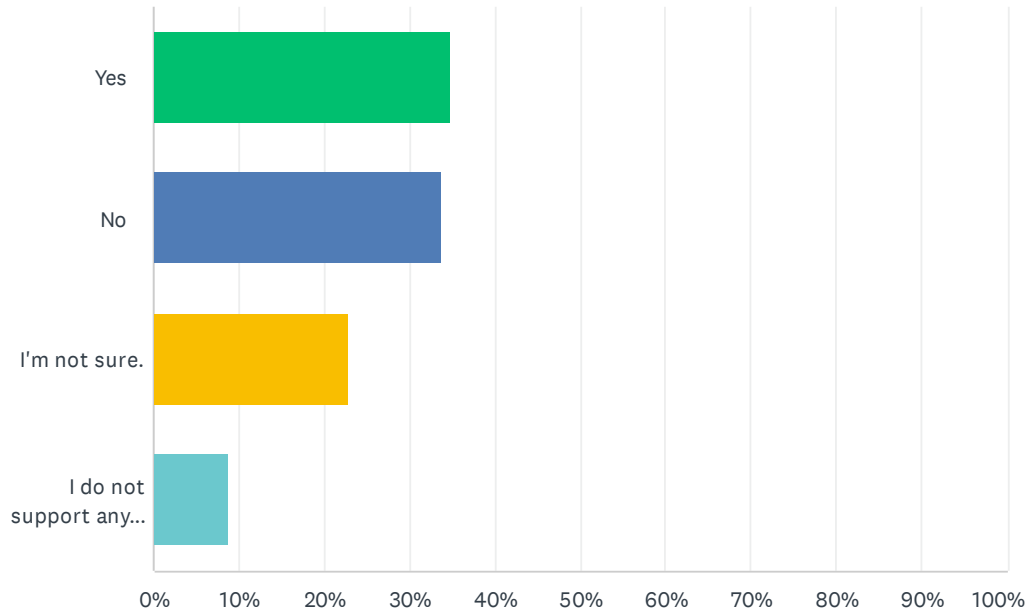
