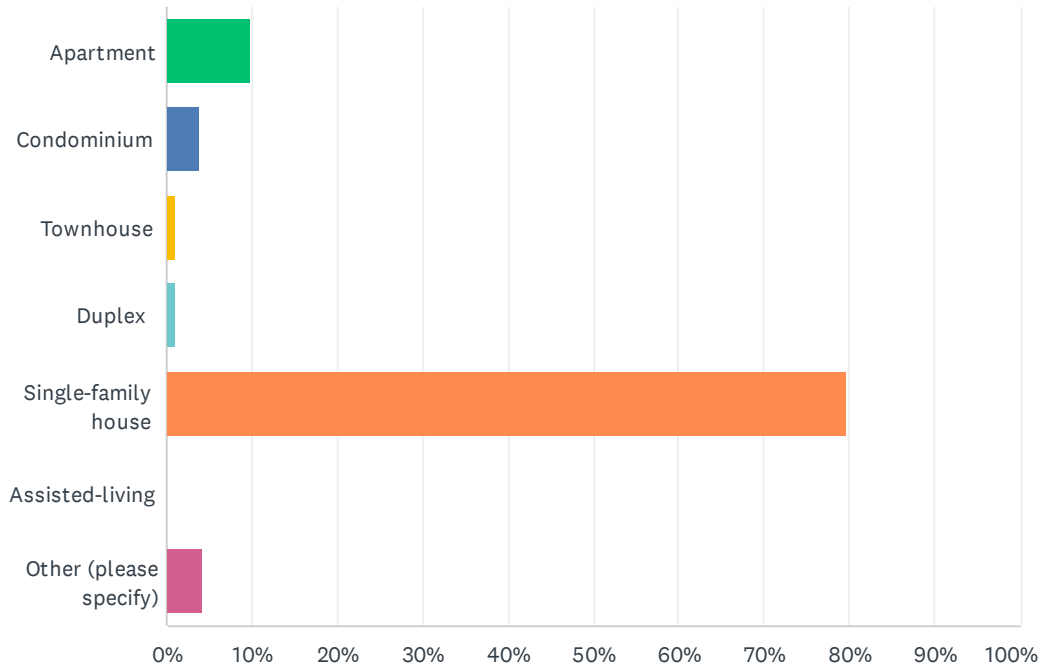

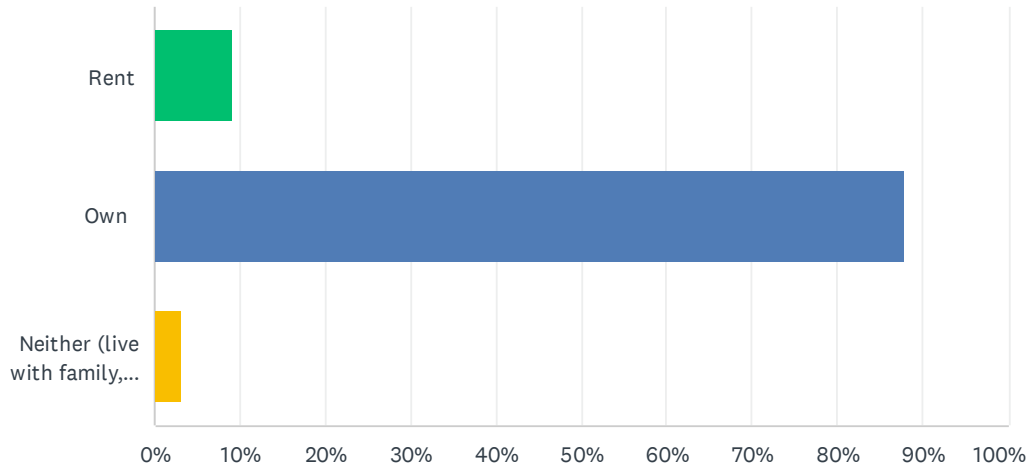

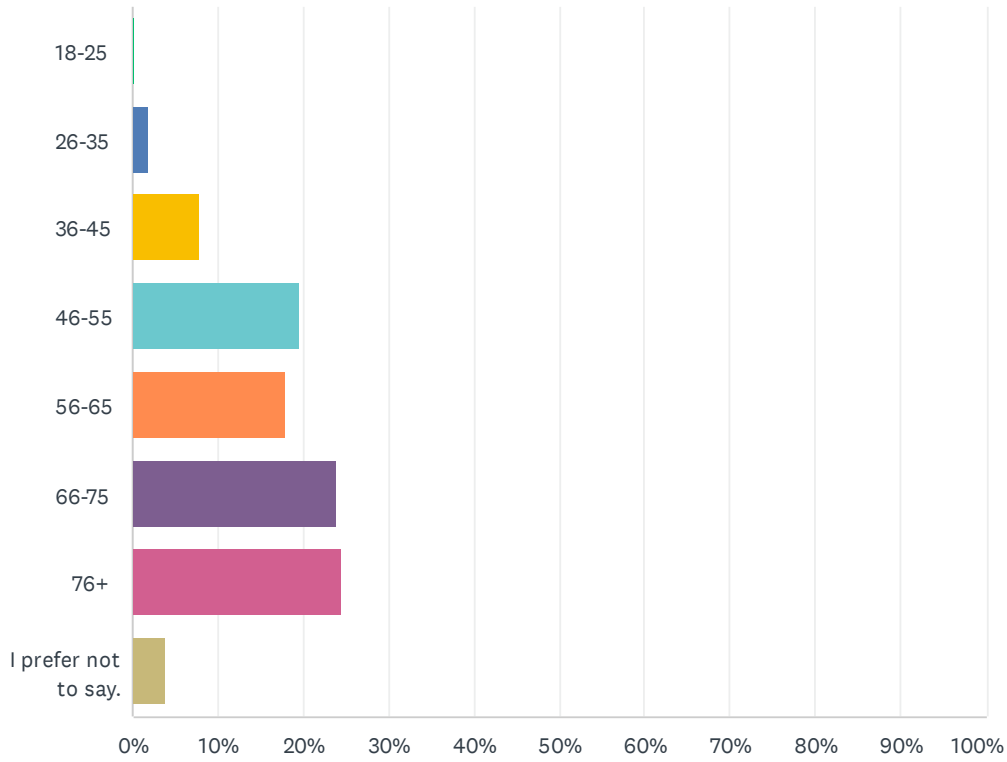

## Q4 What is your age?

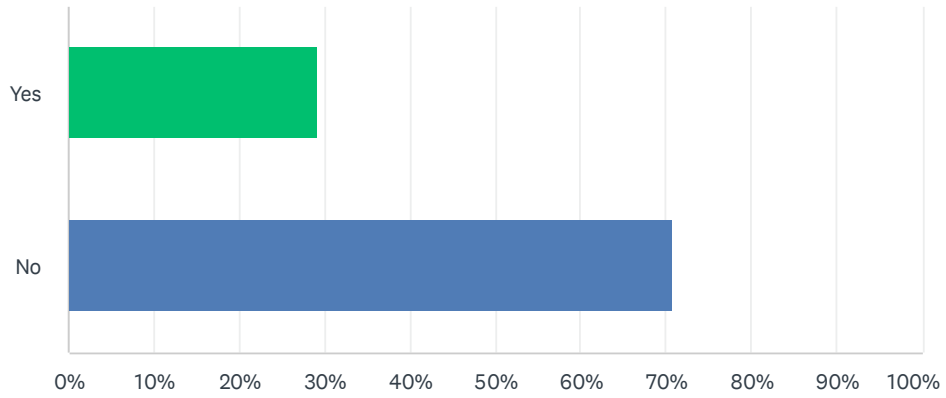

### Q5 Do you have children aged 18 or under living with you?

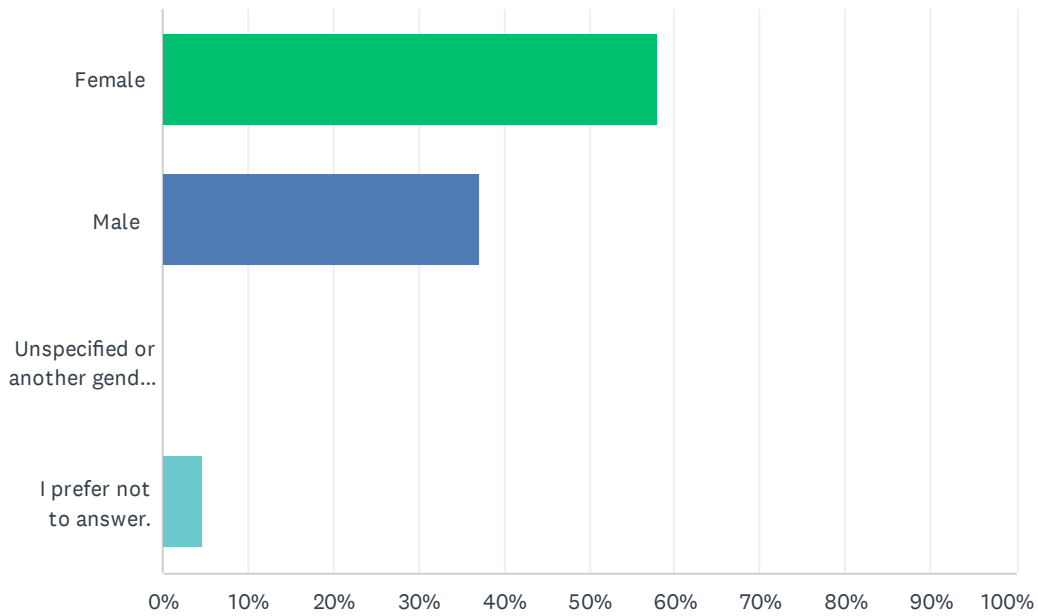

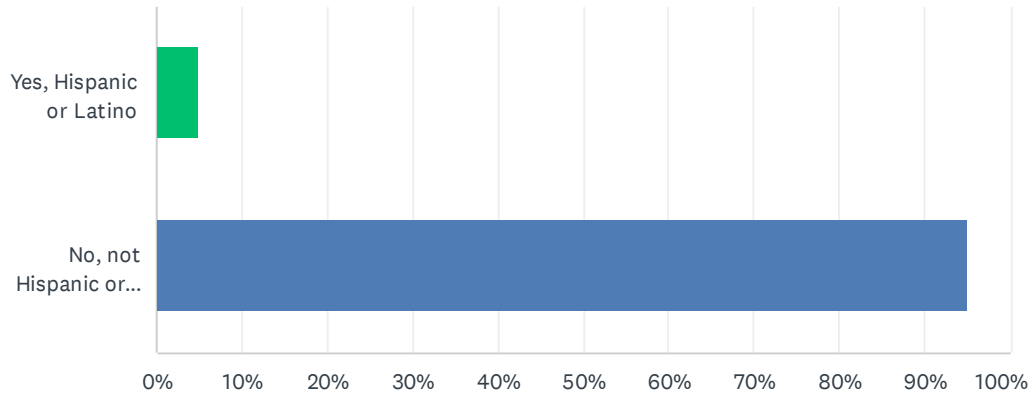

## Q7 Are you Hispanic or Latino?

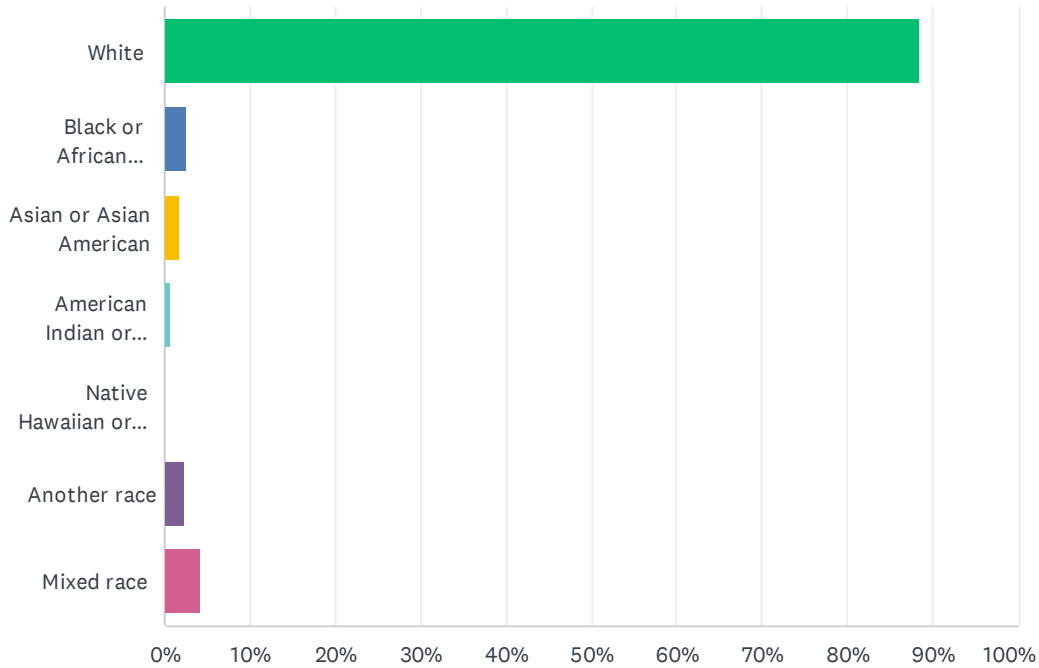

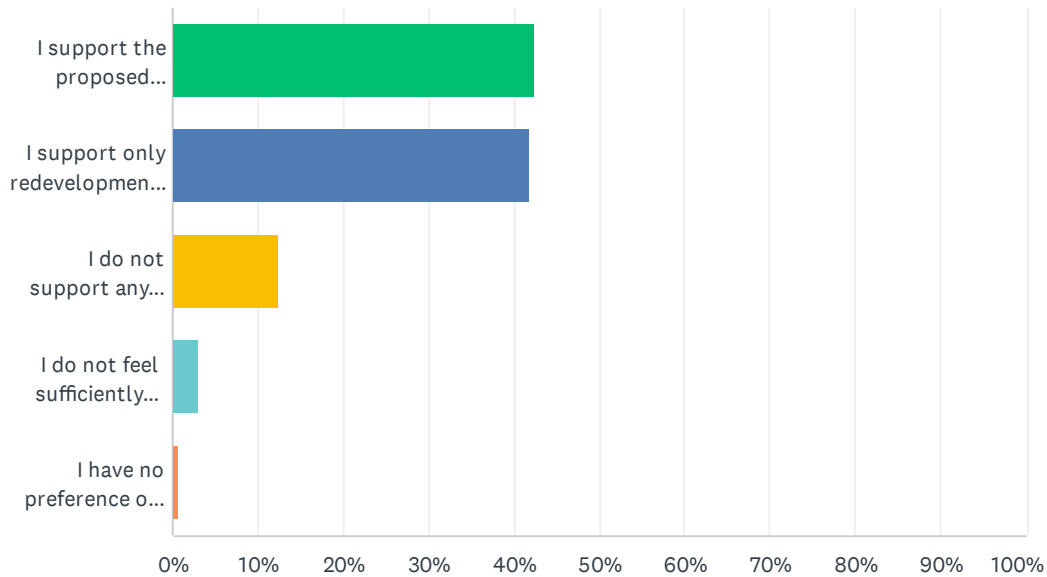

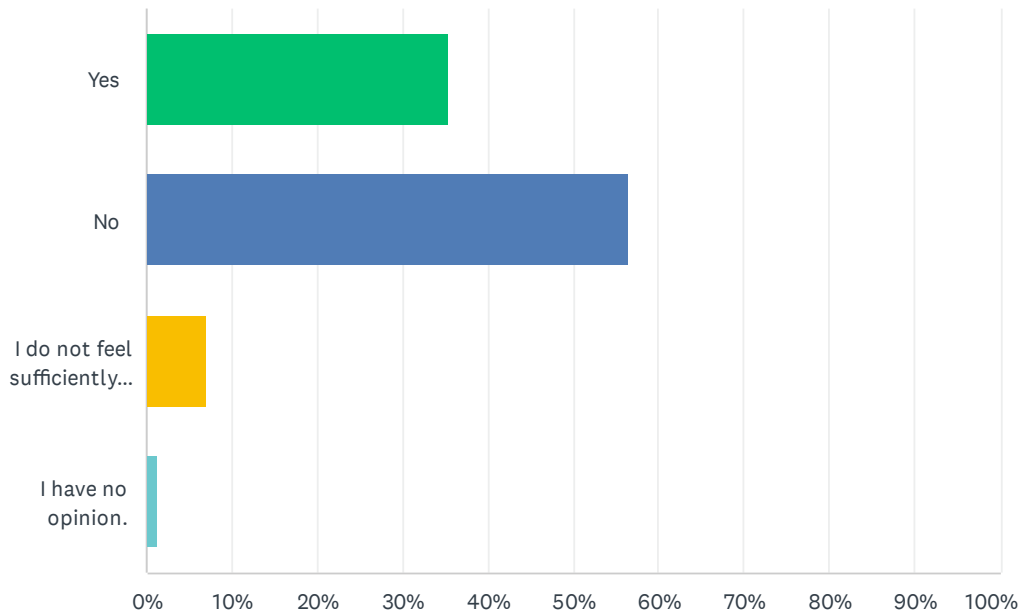

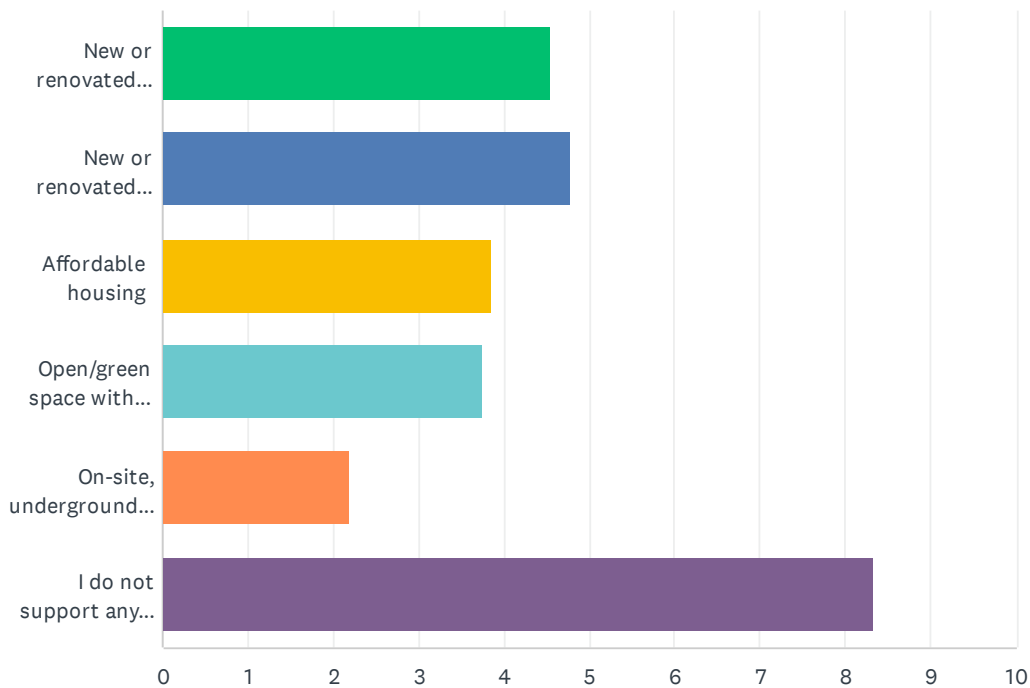

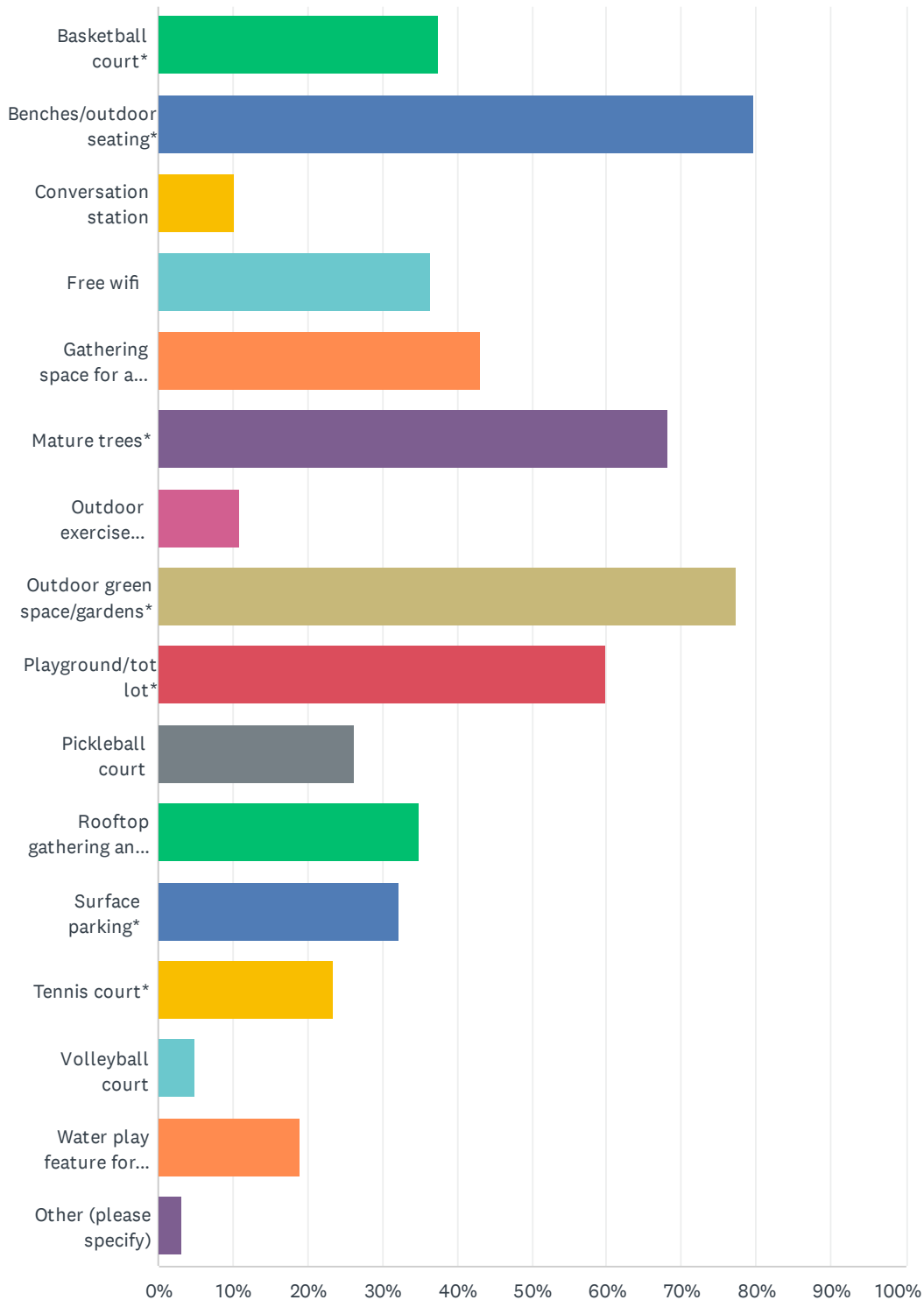

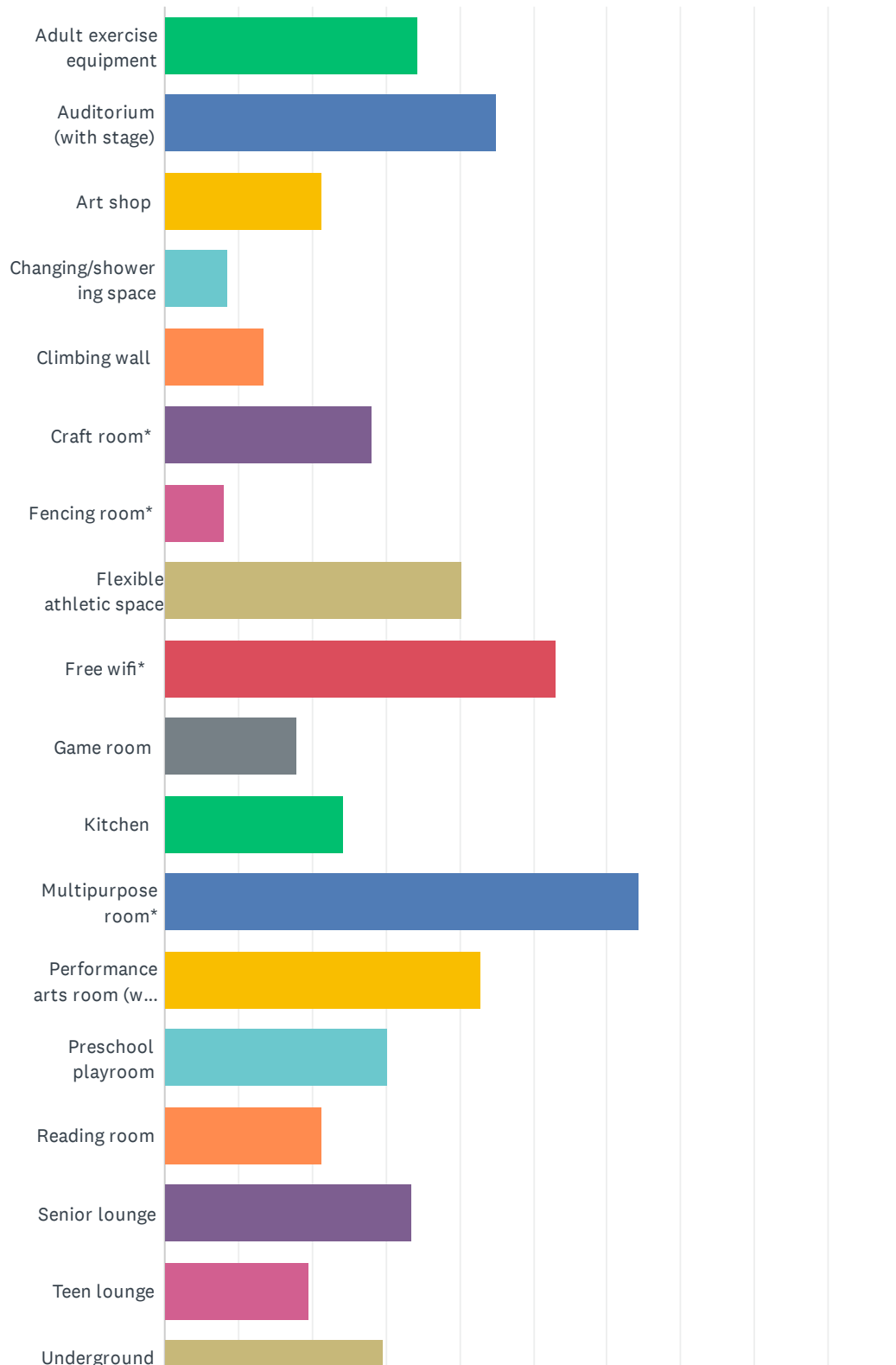

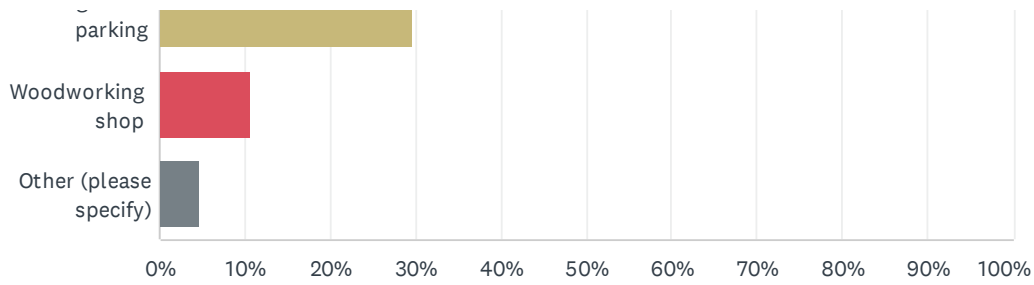
Q14 Which indoor amenities would you most like to have in a new (or renovated) Community Center? Check up to seven. (\* below denotes current amenity).

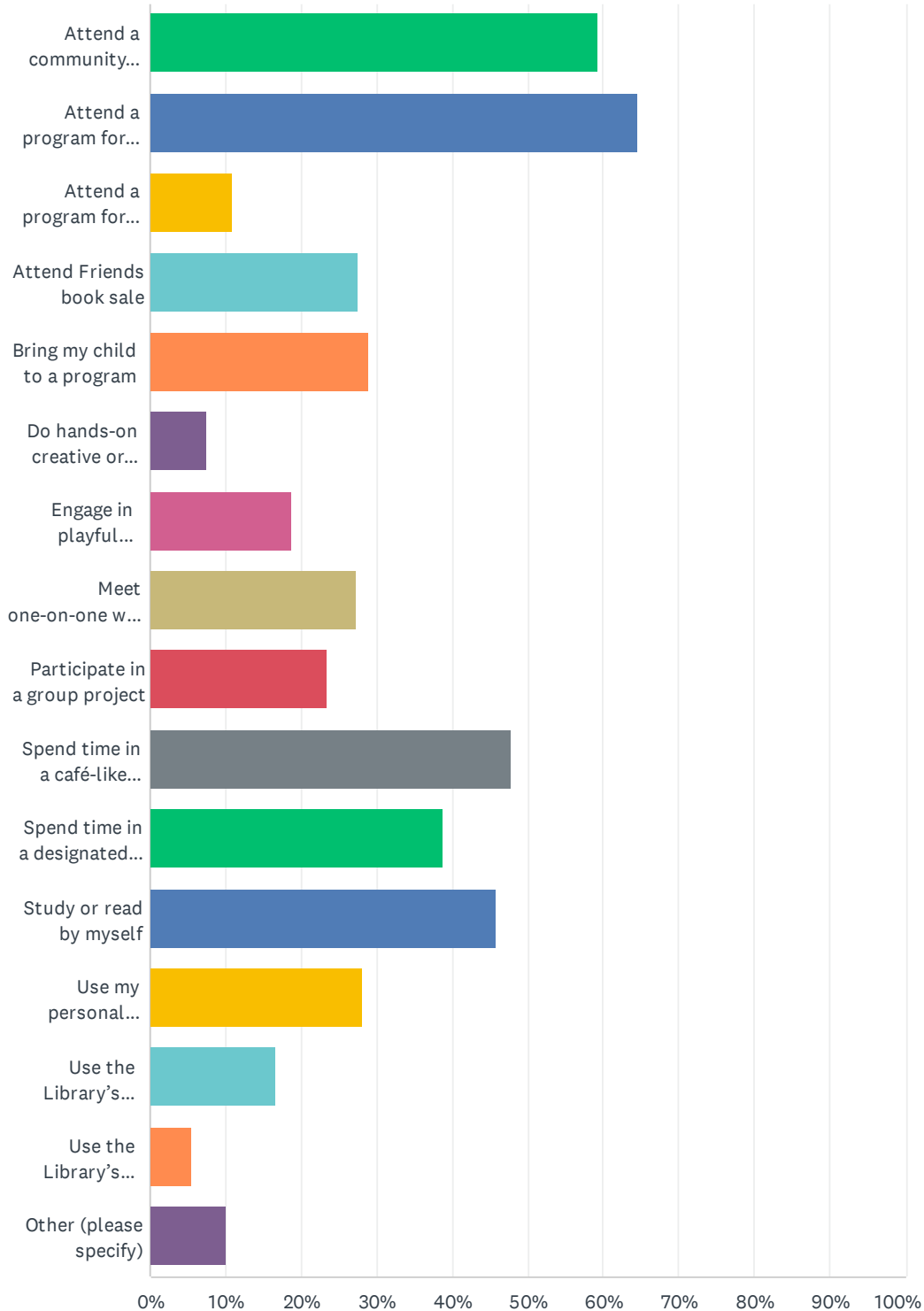

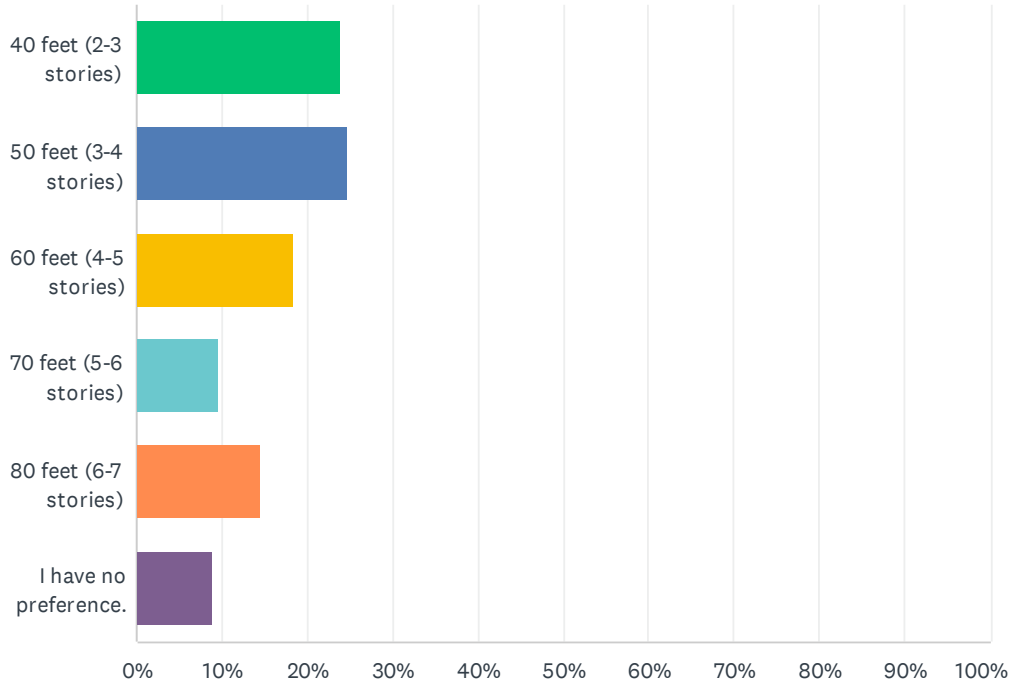

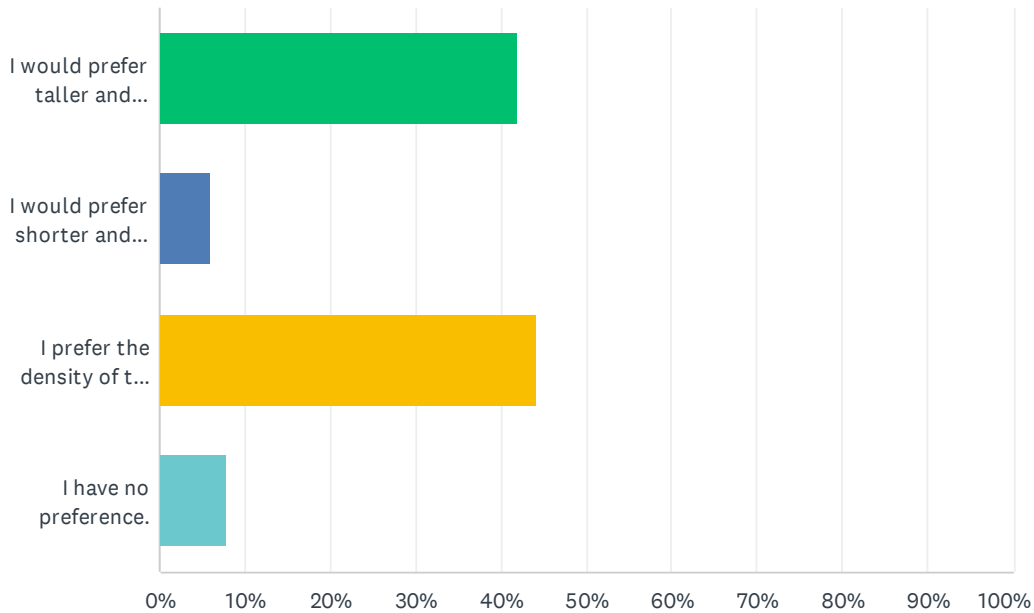

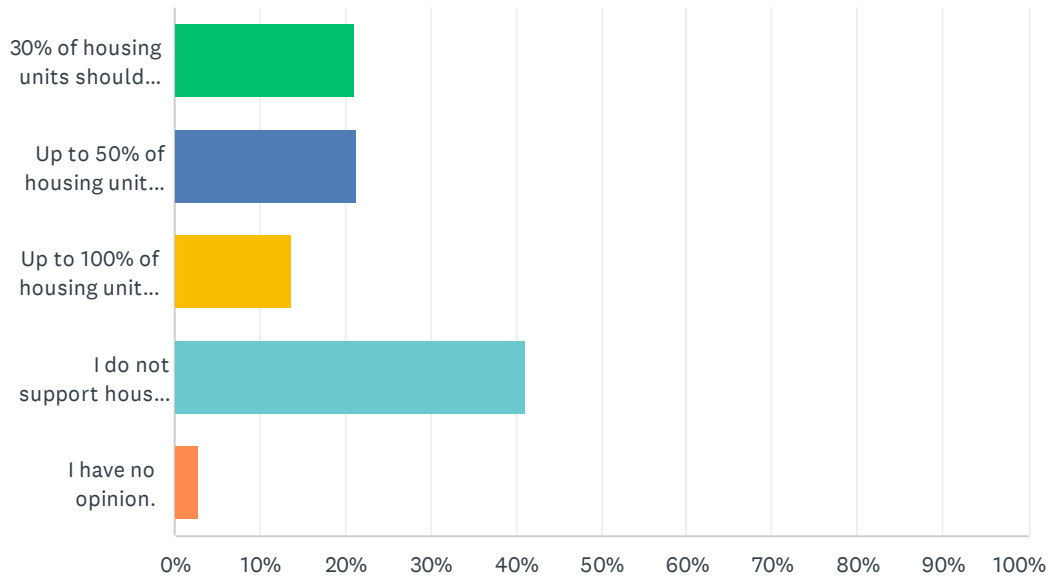

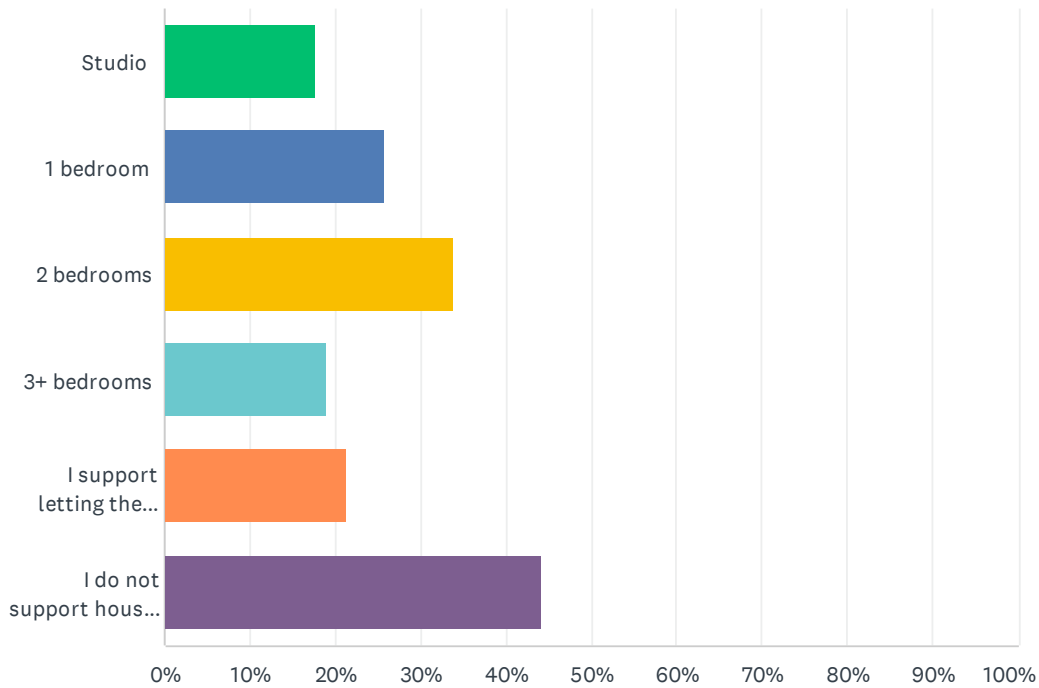

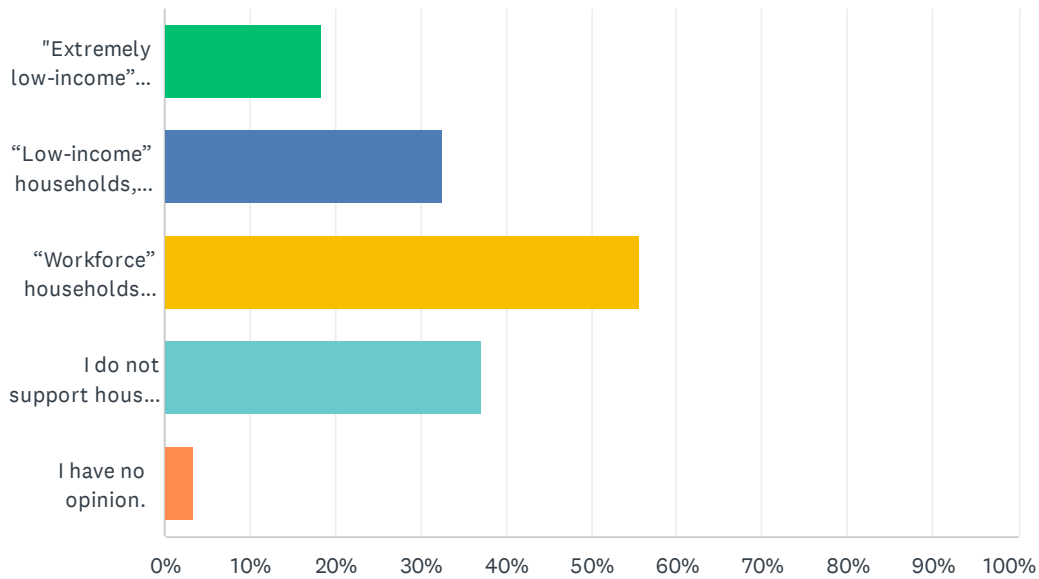

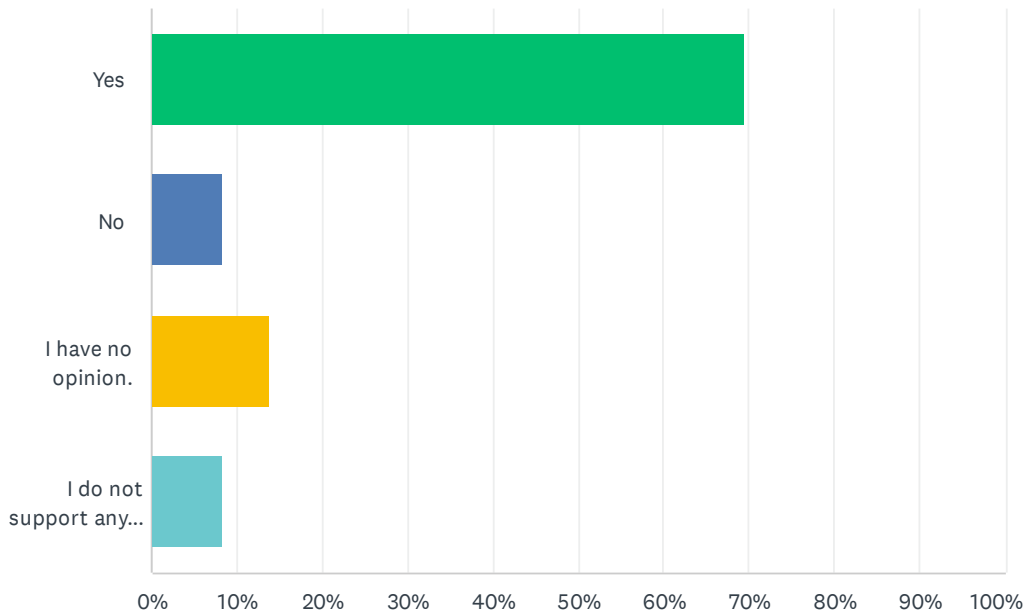

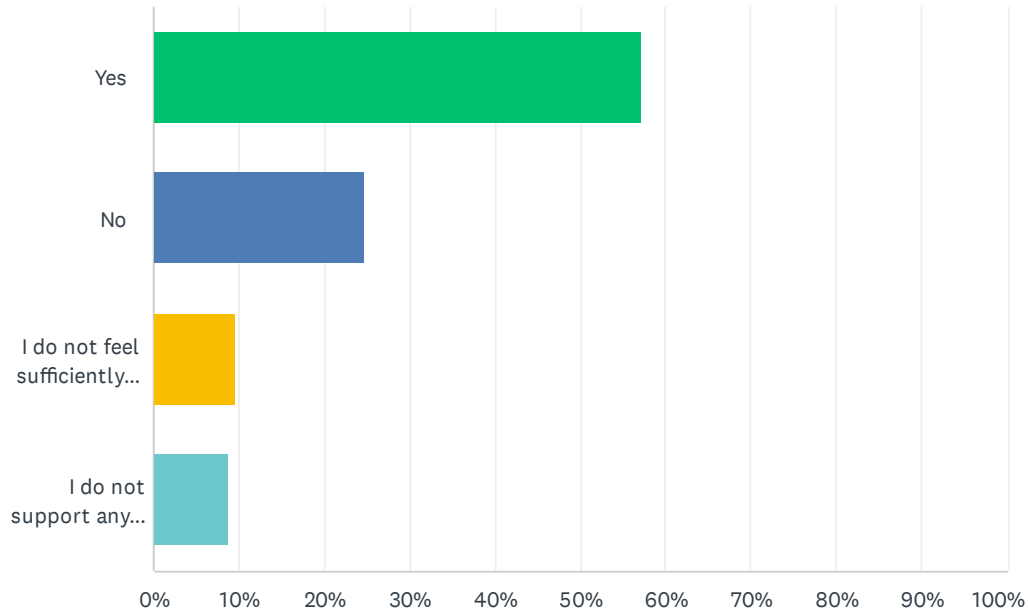

## Q22 A new or renovated Community Center could also include limited retail such as a café. Would you support this?

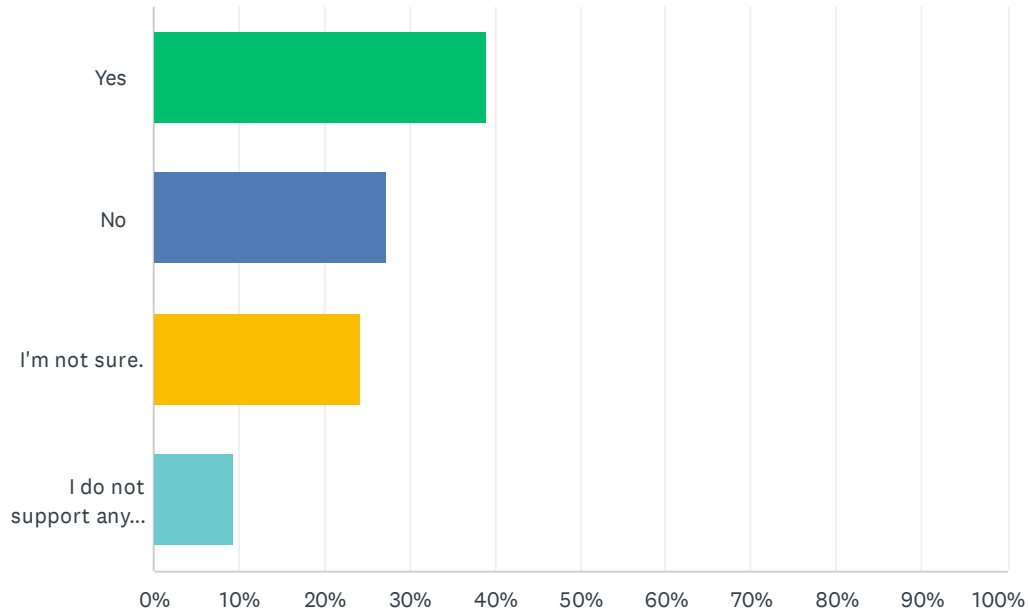
