On behalf of the Commission, I respectfully request a 45-day extension of the public comment period for the Chevy Chase Civic Site Disposition Hearing, currently set to conclude on May 28, 2025.

Following the Commission's May 12th regular public meeting, the ANC unanimously approved the final survey on this phase of the project, which we plan to launch next week. We are confident this extension will enable us to complete the survey, analyze responses, and submit a comprehensive resolution, including all public feedback.


We acknowledge the original 60-day comment period was an extension of the normal amount of time granted, but we ask DMPED to consider the ANC's need for additional time to conduct an inclusive, ANC-wide survey—consistent with our request on November 29, 2022, which was granted.

To ensure meaningful engagement, we request the comment period be extended until no earlier than July 10, 2025. We would appreciate written confirmation of your decision by May 21, 2025.
